Sec. 3. The Secretary shall keep the minutes of the meeting of the Association and of the Board of Directors, and shall preserve all books, records and papers pertaining thereto, and shall attend to such other duties as the Board of Directors may from time to time direct.

Treasurer
Sec. 4. The Treasurer shall keep a record of all receipts and expenditures, countersign and pay all authorized orders drawn on him, and office, or such as may be vested in him from time to time by the Board of Directors or by amend ments to the Constitution and By-Laws.

Sec. 5. In the event one person is elected both Secretary and Treasurer, he shall execute the dutles of both offices as outlined is Sections three and four of this Article.

Deposit of Funds
Section 1. All funds belonging to this Association shall be kept in a bank in the name of The Old Spanish Trail Association to the order of the President and the Treasurer.

Sec. 2. All appropriations and expenditures of money shall be according to regulations formulated by the Board of Directors.

## Annual Budget

Sec. 3. An Annual Budget shall be adopted by the Board of Directors and each county shall be notified of its equitable proportion of this expense.

## Officials, Divisions and Board of Directors

The officers and directors of this Association shall be a President. EVice-President for each division, a Secretary. a Treasurer (the Secretary and the Treasurer may be combined). a Field Engineer, and other officess and directors as the Asw sociation shall elect. These ofiicers and directors, not exceeding twenty-îive in number, shall constitute the Board of Directors.

The Highway shall be divided into as many divisions, with one Vice-President to each division, as the Board of Directors of the Association shall deem wise. The officers and directors residing within a division shall constitute a Divisional Council under the leadership of the Vice-President for matters arising within the division during the interim between meetings of the Board of Directors ox of the Association.

## LOCAL CFFICIALS

Councilors may be appointed in localities along the Treil to act as the local representatives of the Association in all ratters affecting the wort, and for fostering the comfort and pleasures of travelers. Councilors may also serve as aides to Vice-Presidents in the divisional work.
