All these ren have beon membors of the Association Erom the beginning and four of then are mombers of the Advisory Bos.rd. Thoir business standing assures thoir indepondence. To insure a thoro and impsrtial investigation tho public audjtore provioualy employed by the president, and also the attomeys of the Association, vere placed at the commend of this Comittee. Tho president acoepted this committce as setisfactory and agreod to ebido by lts conclusions.

This Comittee, the auditore and the attomoys, apont a nonth inquiring into ali activities. A more audit of booiks doesn't nocesserily show reckless or injudicious disbursenonts, wasterul policies, stupid nothods, illegal conduat or false ropresentation.

This Comittee has boen ready to report since Soptomber 18 th. By one excuso and anothor the meeting of tho Advisory Board to reeolve that report has boon dolayed. Meanvhile in keopine vith my dósire to allow the Comitttce absolute Ireedom I have redxainod Irom assoming control of aifairs. It seoms however that the presldont has taken advantage of this attitude, and instead of awalting the report and recomendations of the Committee and of this Advisoxy Board, bie has gone on nore recklessly than bespre.

This Comaittee now unanimously recomends the resignation of the presidnat. The roportsshow that the policies in force before the period of usurpation vero good and the auditors recomend they be mado the ixxed policies of the Association, and this Comitteo accopts $\lambda$ as propor for the bueinesslike conduct of the work.

The president now roiuses to resigy deapite the fact he pledged himacti beiore this Board to abido by the judgmont oi this Comittee. This final act of discredit. coupled with his continued efforts to conguse the issues with domagogic pretenses nazea it necessary to give the whole story to the public, for as repuibble mion wo cannot continue to keep
